1. NON-RESOLUTION BOARD ITEMS

President Scott Savage called the meeting to order at 8:37 am.

Mr. Scott Savage led the Pledge of Allegiance.

2. CONSENT AGENDA ITEMS

Mr. Fritz Byers made a motion for the disposition of the minutes for the regular Board meeting held on March 26, 2025 and the consent agenda for the meeting on April 23, 2025. This motion was seconded by Mrs. Lera Doneghy and approved.

3. CONSIDERATION OF REPORTS FROM DIRECTOR AND EMPLOYEES OF THE PARK DISTRICT FOR REVIEW

A. Celebrating 50 Years at Wildwood – Scott Carpenter, Art Weber, Jim Kimble

Mr. Savage introduced Mr. Jim Kimble, who was a Metroparks Toledo Board Member from 1977 to 1994, along with Mr. Scott Carpenter and Mr. Art Weber, both with Metroparks Toledo, to share the history of Wildwood Preserve.

Mr. Scott Carpenter provided an overview pertaining to the historical context of Wildwood and how it became a park. He went on to share about how the citizens rallied and came together in order preserve these lands as a park.

Mr. Carpenter stated that in preparation of Wildwood's 50th year anniversary this year, a panel was held last week with Dr. Ted Ligibel, Mr. Art Weber, Mr. Kimble and Steve Pollick sharing the story of how this all came about.

Mr. Weber mentioned that there were several issues with the campaign to save Wildwood, but what we don't speak of is all of the hard work behind the scenes. During this time, there were a variety of socioeconomic issues that they were up against, including very bleak times in general. A proposal was generated that promised work to build an entire new subdivision. Dr. Bill Mewborn encouraged Metroparks to acquire the land because of just how special this property was.

Dr. Mewborn kicked off the campaign by spreading the word and sharing the plan to the community of how special this land was. During that time, he presented to over 120 different groups. From there, he recruited Mr. John Lusk to be the organizer of the actual Citizens Campaign.

As the campaign continued, the group learned that this levy was not favored within the community. However, toward the end of the campaign, Metroparks Toledo Executive Director, Mr. Bob Metz, and Dr. Mewborn met with Mr. Paul Block, owner of The Blade. The Blade, along with other groups and organizations, began to endorse this levy and the tide turned.

Mr. Kimble operated under the mindset that no negative comments were allowed, only positive statements along with a solution to any problem. Mr. Kimble shared that what Metroparks Toledo has accomplished today is unbelievable and simply incredible.

Even after the passage of that levy in 1975, there were still additional steps that had to be made to make the park a reality. The Nature Conservancy purchased the property, giving Metroparks Toledo time to collect the money to buy it.

Ultimately, on June 1, 1975, the gates to Wildwood Preserve opened.

Mr. Byers stated that it's our honor to have you here today Mr. Kimble, and we stand on your shoulders. Mr. Weber and Mr. Kimble, thank you for all of you have done. As stewards for all of the natural and public resources to invest to move the community forward, we trust the legacy that you've implemented, which has led Metroparks Toledo to be the best park district in the United States. All of this hard work and dedication has given us the continued confidence to continue that legacy forward.

Mrs. Doneghy shared that you all are truly a testament of what Metroparks Toledo is all about. Thank you, we could not have done it without you all.

Mr. Savage mentioned that there are many parallels still yet today. We owe everyone that worked on that campaign such gratitude. Metroparks Toledo would not be what we are today without Wildwood. What you all have shared today is so inspiring to continue such a great legacy.

Ms. Luetke mentioned that often people feel hopeless that they can't make a difference. Hearing this today is a great testament to make change by standing up for what you believe in. She went on to share that we all do have capacity to make change locally, against all of the opposition.

B. Treasurer's Report – Matt Cleland, Chief Financial Officer/Treasurer

Mr. Matt Cleland stated that variances are primarily tied to timing. Additionally, you will notice that the tax revenue is down a little, and we will receive fewer dollars as a result of reappraisal corrections that are being processed through the board of revisions. He went on to mention that the utilities are up, which is due to propane tanks filled at Oak Openings Preserve and Secor Metropark. Mr. Dalton inquired how many people have contested their property assessment and Mr. Cleland responded that he read 7,100 but that he did not know if the 1,300 or so class errors were a subset of or in addition to that number.

1. Revenues, Expenditures and Changes in Fund Balances – Budget vs. Actual – General Fund as of 4/30/2025

Description: This report is a comparison of the General Fund budgeted revenues, expenditures and transfers compared to actual revenues, expenditures and transfers by month as well as year-end. The approved 2025 general operating fund budget and actual cash basis revenues, expenditures, and transfers are represented. Year to date budget distribution is based upon a 12 month proration with the exception of salaries and fringe benefits. Salary and fringe benefit budget distribution is based upon a proration of 26 pay dates. (See Appended Statement – Attachment A).

Current State: Sales revenue receipts will catch up next month, with the receipt of ice skating revenue as well as increased seasonal revenue. Interest remains well ahead of budget projections due to higher fund balances that result from a slowdown of construction expense over the winter. The variance in Utilities has decreased slightly since last month.

Prior year revenue and expense rows in Other Sources and Uses will allow for reclassification of prior year transactions without skewing current year reporting.

2. Receipts, Disbursements and Changes in Fund Balances – Budget vs. Actual – All Funds as of 4/30/2025

Description: This report is a comparison of annual budgeted receipts and disbursements compared to cash basis actuals as of month end. The General, Education/Programming, and Debt Service funds are presented as individual columns. The Grant Funds, Land Acquisition/Development, Capital Construction and All Other Funds columns are each summaries of multiple funds. The far right column is a total of all funds. General fund budget and actual numbers presented in this report are consistent with those presented in the report listed above. (See Appended Statement -- Attachment B).

Current State: Reviewing the new prior year rows on the All Funds Budget vs. Actual Report demonstrates the net zero effect of prior year classifications.

3. Fund Advances Report – All Funds as of 4/30/2025

Description: This is a report of inter-fund, Board approved advances activity. Advances are made to support reimbursement grants and activities that would otherwise result in negative fund balances. Advances are returned following the receipt of grant reimbursement revenue.

4. Outstanding Debt Report as of 4/30/2025

Current State: A Property Assessed Clean Energy (PACE) loan from the Northwest Ohio Advanced Improvement Energy District is new on the debt report this month.

Enterprise Fleet Management principal and interest amounts reflect the month's activity.

5. Credit Card Account Review as of 4/30/2025

Description: Per Ohio Revised Code 1545.072 the credit card compliance officer must review the number of cards and accounts issued, the number of active cards and accounts issued, the cards' and accounts' expiration dates, and the cards' and accounts' credit limits and report this information to the board at least quarterly. (See Appended Statement -- Attachment D)

Current State: Josh Brenwell, Credit Card Compliance Officer, has reviewed the attached report and compared it with credit card statements to confirm the accuracy of information provided.

No rewards have been received based on the use of the park district's credit card account for 2025.

6. Investment Ledger as of 4/30/2025

Description: This report is a listing of the Park District's current investment holdings. Current investments are allowable per the Ohio Revised Code and are laddered over a 5-year period. (See Appended Statement -- Attachment E).

Current State: In April, one government security and one certificate of deposit matured. Proceeds from the matured investments were used to purchase a new government security and a new certificate of deposit.

7. Then and Now Report for the month ended 4/30/2025

Description: The Ohio Revised Code (ORC) requires fiscal certification indicating that amounts required for purchases, obligations, contracts, etc. have been lawfully appropriated and are in the treasury or in the process of collection to the credit of an appropriate fund free from any previous encumbrances. Then and now is a certification by the Board that funds were available when an obligation was made (then) and at the time of certification (now) for obligations made prior to certification. (See Appended Statement -- Attachments F).

Current State: There are two purchase orders requiring certification by the board for the month of April.

DESCRIPTION:

The 2025 Annual Appropriations Measure was approved by the Board at the November 2024 Board Meeting. Additional supplements to the 2025 Certificate of Estimated Resources and Appropriations Measure are needed to address supplements as summarized below. The affected line item appropriations and Certificate of Estimated Resources are attached.

The affected funds are as follows:

Fund 256 - U.S. Department of the Treasury - Metropark Development & Construction of Glass City Enrichment Center (Lucas County)

Increase appropriations in the amount of \$1,500,000 for the purpose of reconciling prior year grant expenditures. This increase brings the total of appropriations in fund 256 to \$26,087,993.

Fund 256 - U.S. Department of Justice - COPS Hiring Program 2020-2023

Increase appropriations in the amount of \$137,773 for the purpose of reconciling prior year grant expenditures. This increase brings the total of appropriations in fund 256 to \$26,225,766.

Fund 256 - Institute of Museum and Library Services - Toledo Botanical Garden

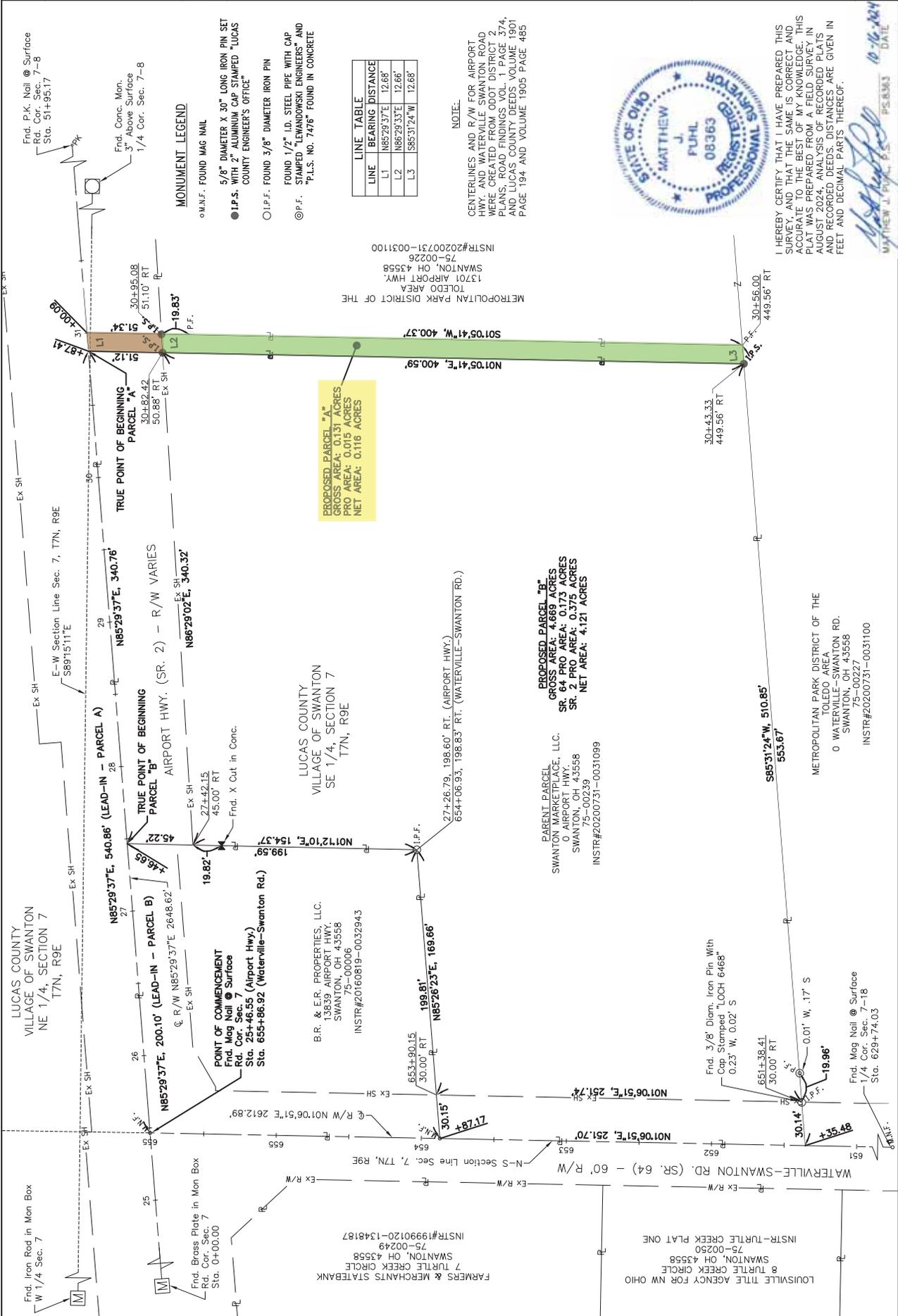

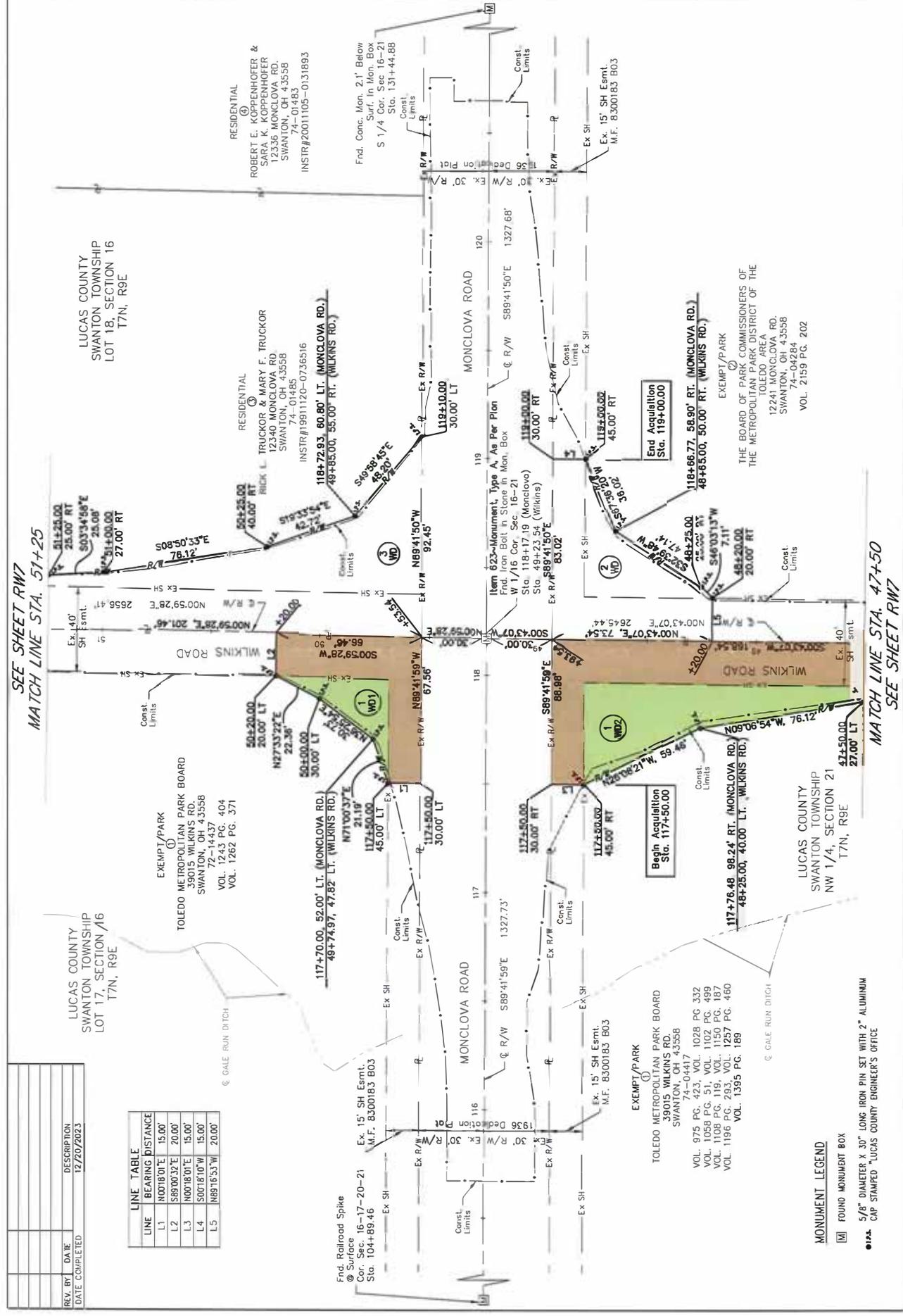
