**1. NON-RESOLUTION BOARD ITEMS**

President Scott Savage called the meeting to order at 8:42 a.m.

Mr. Savage led the Pledge of Allegiance.

**2. CONSENT AGENDA ITEMS**

Mr. Fritz Byers made a motion for the disposition of the minutes for the regular Board meeting held on October 15, 2025. This motion was seconded by Ms. Molly Luetke and approved.

**3. CONSIDERATION OF REPORTS FROM DIRECTOR AND EMPLOYEES OF THE PARK DISTRICT FOR REVIEW**

A. Current Research and Partnerships in the Oak Openings Region: Green Ribbon Initiative – Jay Wright, Director of Conservation Science

Mr. Jay Wright began his presentation by explaining his increasing involvement with the Green Ribbon Initiative (GRI).

What is the GRI?

The Green Ribbon Initiative is a conservation partnership focused on protecting a globally rare ecosystem made up of oak savanna, dry and wet prairies, sand barrens, and flatwoods. This natural community extends across northwest Ohio and into Michigan, with Metroparks Toledo owning much of the protected land. The two largest partners in the GRI are Metroparks Toledo and The Nature Conservancy, and the collaboration has maintained strong relationships across its partner organizations for roughly 25 years.

GRI Structure

The organization operates with a central steering committee supported by five specialized committees:

- Science
- Land Protection
- Stewardship
- Native Plants
- Outreach & Education

Land Protection Committee (newly re-formed) which focuses on:

- Sharing tools and resources for land acquisition and ecological restoration
- Updating land cover data for the habitat sustainability model
- Refining priority conservation areas
- Developing a parcel reviewer tool, created by Josh Brenwell, GIS Manager at Metroparks Toledo

Mr. Wright presented on reptile and small mammal monitoring using AHDrift Arrays, a technique designed to detect species that are often difficult to observe directly.

How AHDrift Arrays Work:

- A low barrier or “fence” is installed in an open area.
- Animals encountering the fence are funneled toward a bucket trap.
- Each bucket contains a camera that automatically photographs the animals.
- The setup allows detection of elusive or cryptic species.
- This work is conducted in partnership with Ohio State University (OSU).

Objectives of the Monitoring System:

- Assess wildlife community composition across the region
- Monitor a wide variety of habitat types
- Evaluate ecological impacts of fire, mowing, and other management tools
- Compare conditions before and after cattle grazing in prairie systems

Monitoring Season: Deployed early May through late October

The AHDrift Arrays have recorded approximately 30,000 capture events. Most detections were mammals, but data also include snakes, amphibians, birds, turtles, and invertebrates.

Common Small Mammals

- Meadow vole

- Meadow jumping mouse
- Shrews
- Chipmunks
- Groundhogs
- Minks

#### Snake Species Documented

- Eastern gartersnake
- Blue racer
- Eastern hognose snake

#### Restoration and Management Findings

##### Before Pine Stand Removal

- High numbers of squirrels, chipmunks, and mice
- Almost no amphibians
- No snake detections

##### After Pine Stand Removal

- No squirrels or chipmunks
- Large increases in voles and mice
- Hundreds of toads
- Hundreds of blue racer snakes

##### After Prescribed Burn and Re-Seeding

- More voles and mice
- Fewer snakes and shrews
- Further analysis is ongoing to determine underlying causes

Mr. Wright continues to analyze data to understand how management actions influence wildlife communities.

Mr. Byers praised the report, noting how impressive it is to capture and manage such a substantial volume of detailed ecological data. He emphasized that the broad involvement of partner organizations aligns strongly with the Metroparks Toledo Vision.

He remarked that, even on a national scale, Metroparks Toledo is working with some of the most important conservation organizations, all deeply dedicated to preserving the region's natural future. He commended Mr. Wright and his staff for their significant accomplishments.

Mr. Savage asked about the biggest accomplishments achieved by the GRI over its 25-year history. Mr. Wright identified the creation of the Oak Openings Corridor as one of the most significant achievements, noting the key leadership role of Dr. Tim Schetter. The corridor represents a major collaborative effort to connect habitat across northwest Ohio and into Michigan.

He emphasized that the continued collaboration and communication among all GRI partners remains one of the initiative's most meaningful and impactful successes.

B. Treasurer’s Report – Matt Cleland, Chief Financial Officer/Treasurer

Mr. Cleland shared that everything is trending as expected, noting however that the budget to actual variances are much closer than normal. The finance team is monitoring budgets and expenditures closely and will request adjustments if necessary at the December board meeting.

A. Mr. Byers offered and moved for adoption of the following resolution, with a second by Ms. Luetke:

Mr. Cleland shared that a check was sent to Metroparks Toledo and learned later that it was meant for the Metroparks Toledo Foundation. This is to formalize re-directing the funds to the foundation.

After discussion and upon unanimous vote the resolution was declared duly adopted and recorded in the appendix to these minutes.

B. Ms. Luetke offered and moved for adoption of the following resolution, with a second by Mrs. Doneghy:

Resolution No. 83-25 2026 Appropriation Measure

After discussion and upon unanimous vote the resolution was declared duly adopted and recorded in the appendix to these minutes.

C. Mrs. Doneghy offered to move for adoption of the following resolution, with a second by Mr. Byers:

Resolution No. 84-25 Ratification of Schedule of Payables

After discussion and upon unanimous vote the resolution was declared duly adopted and recorded in the appendix to these minutes.

D. Mrs. Doneghy offered to move for adoption of the following resolution, with a second by Ms. Luetke:

Resolution No. 85-25 Approval of Federal Cost Share Agreement with The Department of the Army Corps of Engineers

Ms. Zuri Carter stated that this is an approval to perform an environmental study at Keil Farm. This study will take 2-3 years and based on the results, Metroparks Toledo can choose to move forward or not. Mr. Byers inquired how Metroparks Toledo will engage with the Federal Government and community stakeholders during this process. Ms. Carter said we will know more at the end of the study, but Metroparks Toledo will be involved. Mr. Dave Zenk shared what’s most important about this is it sets us up if and when we’re ready to move forward. Mr. Byers said this was a really great initiative and is important for community response with Keil Farm.

After discussion and upon unanimous vote the resolution was declared duly adopted and recorded in the appendix to these minutes.

E. Ms. Luetke offered to move for adoption of the following resolution, with a second by Mrs. Doneghy:

Resolution No. 86-25 Contract Approval, Prairie & Baselgia Ditch Restoration Design-Build Project

Mr. Byers inquired as to the timeframe for this project, and Ms. Carter said this will start late 2026 and go into early 2027. This will be fully funded with the grant.

After discussion and upon unanimous vote the resolution was declared duly adopted and recorded in the

appendix to these minutes.

- F. Mrs. Doneghy offered to move for adoption of the following resolution, with a second by Mr. Byers:

Resolution No. 87-25 Contract Approval, Services Agreement, Shumaker Advisors, LLC

Mr. Matt Killam shared that we have contracted with two agencies to assist with lobbying efforts, at the state and federal level. These agencies help Metroparks Toledo to hone in on what projects are most essential to our region. Mr. Byers inquired if it's a monthly expense and we can terminate at any time. Mr. Killam responded that yes, it is.

After discussion and upon unanimous vote the resolution was declared duly adopted and recorded in the appendix to these minutes.

- G. Mr. Byers offered to move for adoption of the following resolution, with a second by Ms. Luetke:

Resolution No. 88-25 Contract Approval, Services Agreement, Smith Garson, Inc.

Mr. Killam shared this group helps organizations within the Toledo region to travel Washington D.C. for lobbying efforts.

Ms. Heather Mosqueda stated that laws were put in place regarding cybersecurity that Metroparks Toledo must adhere to. The three main areas include:

- Do not want public agencies to pay ransoms
- Establish a cybersecurity program, which we have had in place.
- There are required reportings with dates and times pertaining to this program

After discussion and upon unanimous vote the resolution was declared duly adopted and recorded in the appendix to these minutes.

- I. Mrs. Doneghy offered to move for adoption of the following resolution, with a second by Mr. Byers:

Resolution No. 90-25 Extension of New Era Information Technology Support Services Contract (New Era)

Ms. Carrie Haddix stated that Metroparks Toledo is in the process of implementing Office 365 and New Era is the vendor that has begun the rollout.

After discussion and upon unanimous vote the resolution was declared duly adopted and recorded in the appendix to these minutes.

- J. Mr. Byers offered to move for adoption of the following resolution, with a second by Ms. Luetke:

Ms. Haddix shared that with the additional staff, there are additional costs that come with that pertaining to the payroll and HR program.

After discussion and upon unanimous vote the resolution was declared duly adopted and recorded in the appendix to these minutes.

- K. Ms. Luetke offered to move for adoption of the following resolution, with a second by Mrs. Doneghy:

Resolution No. 92-25 Authorization to Request Funding Through the Ohio Department of Natural Resources (BIG)

Mr. Allan Gallant shared that this is a new grant that funnels through state agencies for boating infrastructure assistance. This is for a transient dock to be placed behind 1030 Water Street. We have been approved and Metroparks Toledo was the only one that applied for this tier. Expect to be awarded in 2026.

After discussion and upon unanimous vote the resolution was declared duly adopted and recorded in the appendix to these minutes.

- L. Mrs. Doneghy offered to move for adoption of the following resolution, with a second by Mr. Byers:

Resolution No. 93-25 Authorization to Request Funding Through the Ohio Department of Natural Resources (LWCF)

Mr. Gallant shared that this is federal money that flows through the Ohio Department of Natural Resources. These funds would upgrade the playground at Side Cut, including making it more inclusive.

After discussion and upon unanimous vote the resolution was declared duly adopted and recorded in the appendix to these minutes.

- M. Mr. Byers offered to move for adoption of the following resolution, with a second by Ms. Luetke:

Resolution No. 94-25 Authorization to Request Funding Through the Ohio Lake Erie Commission

Mr. Gallant shared that these are GLRI funds that ideally will award one project that will engage with the community. While working with Ms. Carter and Natural Resources, the project will include performing invasive species removal at Swan Creek as well as having youth engaged and surrounding neighborhoods engaged as well. This will be submitted in late December, and hoping to hear first quarter of 2026.

After discussion and upon unanimous vote the resolution was declared duly adopted and recorded in the appendix to these minutes.

5. BOARD INITIATED TOPICS AND DISCUSSION

Mr. Eric Varner introduced Metroparks Toledo new ranger, Sean LaPlante. He joins the team with 30 years or previous service with the Sheriff's Department.

### 1. Revenues, Expenditures and Changes in Fund Balances – Budget vs. Actual – General Fund as of 11/30/2025

**Description:** This report is a comparison of the General Fund budgeted revenues, expenditures and transfers compared to actual revenues, expenditures and transfers by month as well as year-end. The approved 2025 general operating fund budget and actual cash basis revenues, expenditures, and transfers are represented. Year to date budget distribution is based upon a 12 month proration with the exception of salaries and fringe benefits. Salary and fringe benefit budget distribution is based upon a proration of 26 pay dates. (See Appended Statement – Attachment A).

**Current State:** Interest Income and All Other Revenue are the primary drivers of the positive revenue budget to actual variance. The annual Workman’s Compensation payment was made in November which brings fringe benefits to the current seven percent variance. Capital Outlay expenses exceed the budget as a result of improved account classification, budget adjustments between categories supported these expenses.

### 2. Receipts, Disbursements and Changes in Fund Balances – Budget vs. Actual – All Funds as of 11/30/2025

**Description:** This report is a comparison of annual budgeted receipts and disbursements compared to cash basis actuals as of month end. The General, Education/Programming, and Debt Service funds are presented as individual columns. The Grant Funds, Land Acquisition/Development, Capital Construction and All Other Funds columns are each summaries of multiple funds. The far right column is a total of all funds. General fund budget and actual numbers presented in this report are consistent with those presented in the report listed above. (See Appended Statement -- Attachment B).

**Current State:** Budgets for Salaries and Fringe Benefits in the Education/Programming and Other Funds will receive transfers and supplements as necessary to cover total annual expenses. Capital Construction expenditure exceed annual budget amount due to payments having been made against prior year encumbrances.

## **DESCRIPTION:**

The 2025 Annual Appropriations Measure was approved by the Board at the November 2024 Board Meeting. Additional supplements to the 2025 Certificate of Estimated Resources and Appropriations Measure are needed to address supplements as summarized below. The affected line item appropriations and Certificate of Estimated Resources are attached.

The affected funds are as follows:

### **Fund 202 - Buckeye**

Increase appropriations in the amount of \$54,778 for various donation supported initiatives. This increase brings the total of appropriations in fund 202 to \$9,369,239.

### **Fund 256 – Howard Marsh Phase Two – Ducks Unlimited/NOAA**

Increase appropriations in the amount of \$2,847,560 to support the reclassification of prior year expense to close out of the grant. This increase brings the total of appropriations in fund 256 to \$29,757,344.

## **DESCRIPTION:**

Ohio Revised Code §5705.41(D) states, in part, that “Fiscal Officers may prepare so-called ‘blanket’ certificates for a sum not exceeding an amount established by resolution or ordinance adopted by the members of the legislative authority against any one specific line item account over a period not running beyond the end of the current fiscal year.”

*Current State:* Part of the Park District’s financial controls is the use of varying types of purchase orders. Another of the Park District’s financial controls is a purchasing policy requiring competitive bidding and Board approval for purchases exceeding \$50,000. In accordance with the Ohio Revised Code as noted above, an amount/limit, per blanket purchase order, prepared/authorized by the Fiscal Officer, needs to be established by the Board. Issuance of blanket purchase orders for amounts up to \$50,000 would be consistent with already established policy. Blanket purchases exceeding this amount will be independently presented to the Board for approval via resolution.

## **RECOMMENDATION:**

Approve Park District use of blanket purchase orders, prepared/authorized by the Fiscal Officer, that can be issued in amounts not exceeding \$50,000, and consistent with law. Blanket purchases exceeding this amount will be independently presented to the Board for approval via resolution or ordinance.
