1. NON-RESOLUTION BOARD ITEMS

President Scott Savage called the meeting to order at 8:37 a.m.

Mr. Scott Savage shared that the Glass City Riverwalk update event hosted by the Philanthropy Department on April 19, 2022 was terrific. He thanked Ms. Ally Effler and the team for a great event. Mr. Savage observed that it is important that all the workers and volunteers know that everything they do is very much appreciated, not only for the Glass City Riverwalk project but all of Metroparks.

Mr. Savage led the Pledge of Allegiance.

2. CONSENT AGENDA ITEMS

Mr. Fritz Byers made a motion to approve the consent agenda for the disposition of the minutes for the regular Board meeting held on March 16, 2022. This motion was seconded by Mrs. Lera Doneghy and approved.

3. CONSIDERATION OF REPORTS FROM DIRECTOR AND EMPLOYEES OF THE PARK DISTRICT FOR REVIEW

- A. Glass City Metropark & Riverwalk Update
 - Dave Zenk, Executive Director
 - Allison Marusic, PLA, ASLA, Associate/Landscape Architect at SmithGroup
 - Claire Weisz, Founding Principal at WXY

Mr. Dave Zenk began the presentation by focusing on the 5 miles of Riverwalk and 300 acres of land. He shared that Metroparks Toledo reached this point in the project because of the Downtown Toledo Master Plan, which spoke about a bold vision of a completely rebuilt, accessible, and activated riverfront that connects both sides of the Maumee River and creates new opportunities for downtown and neighborhood redevelopment and reinvestment. Through new park spaces, a network of connected and pedestrian-friendly streets, and focused infill development, Downtown Toledo can begin to knit its urban fabric back together.

Mr. Zenk observed that creating new parks and trails downtown brings Metroparks Toledo's Mission and Vision to the Downtown Toledo Master Plan, focusing on both sides of the river. At the same time, Metroparks Toledo, under the leadership of its Board of Park Commissioners, has its own master plan to expand its services to the community by bringing nature to neighborhoods in Metroparks Toledo's largest city.

Mr. Zenk then introduced Ms. Allison Marusic, Landscape Architect with SmithGroup, to provide an update on Glass City Metropark Phase 2.

Ms. Marusic reported that SmithGroup has been involved with designing park features at Middlegrounds, Howard Marsh, Manhattan Marsh, and now Glass City. The goals for Glass City Metropark include honoring values and expectations expressed by the community; incorporating local, state, and national trends in recreation and accessibility; connecting the Toledo community back to its waterfront; advancing regional connectivity; and enhancing environmental features by prioritizing reforestation, improving water quality, and adhering to the 80/20 rule of park development (80% natural/20% built).

Ms. Marusic further discussed the site history. Because this site is on the edge of the river, over time as industry came to the area, land was slowly filled in with material which was not favorable, including fly ash. Conservation is critical to this project, which is supported in the 80% natural/20% built goal. The site connects people to parks and parks to people, and provides neighborhood connection points. The new pedestrian bridge promotes connectivity over Main Street and connects Glass City and International Park. The site also offers access to the Maumee River, and opportunities for engagement with fishing, viewing, kayaking, and boating.

Ms. Marusic noted that Phase 2 includes play nodes, habitat islands, a transit boat dock, Little Maumee play area, skating ribbon, skating pod, misting towers, plaza and market hall (an all season hub with dining, restrooms, and an indoor/outdoor fireplace), and themes of emerging forest (tree canopy). It also includes a Rain Tower plaza, a water play feature in the summer, and a fire-pit feature in winter. Cabanas will be available to reserve for the day or by the hour. Graphite Design is incorporating local history into art pieces for the project. Discovery play will provide opportunities to learn and connect with nature while having fun, cultivating physical and social wellbeing through hands-on experiences, and offering opportunities for visitors to engage in self-determined, multi-seasonal, intergenerational, critical thinking, risk taking, and knowledge construction activities. Ms. Marusic stated that the Mini Maumee will feature interactive water play, a natural pond for interactive observation, a waterfall, and a scaled "map" of the Maumee River and its tributaries. The Prairie and Pollinator Plat Node will feature wood adventure play elements, a prairie maze experience, interpretive planting/garden areas for educational engagement, and mounds with tunnels where kids can play. The Woodland Play Node will feature a 40-foot tower with multiple ways to engage with nature and play, and it will feature an accessible bridge connection over walkways to the sled hill slope, embankment slides, and a zip line. The Urban Camping Experience, not yet under construction but beginning soon, will feature camping sites as well as eco huts for overnight stays. This will allow visitors to stay overnight in the park while enjoying community events, the National Museum of the Great Lakes, the marina, downtown, and more.

Mr. Zenk stated that he is always asked which is his favorite park, but he ultimately cannot pick just one. Lately Mr. Zenk also has been asked what his favorite part of Glass City Metropark is, and again, he cannot choose one. Mr. Zenk observed that this will be one of the best river front areas in the country, and emphasized that Metroparks Toledo must remain focused on urban conservation and never lose sight of it.

The next phase builds momentum for the Glass City Riverwalk. Mr. Zenk introduced Ms. Claire Weisz from WXY Architecture + Urban Design from New York City.

Ms. Weisz discussed being part of a very large team. She noted that all of this only started in September 2021, and that in other cities it often takes many years to design a Riverwalk. Ms. Weisz stated that this is a transformation of waterfronts, and that people from around the world are looking at how the United States is handling waterfront transformations as part of a global trend. She described transforming industrialized areas to commercialized play and ecological areas, and how these transformations bring people and nature together.

Ms. Weisz explained the focus on design, and shared that the ingredients are parts of the future. She described what is happening at Glass City Metropark in the context of the active and passive, and observed that, right now, this is a place for individual and collective groups together. Ms. Weisz stated that "the future is now" to work on the riverfront. She identified the design drivers, which she also referred to as the "language of the Riverwalk," including: Drift & Meander — connected and multi-modal; Exploration & Play — be accessible and inclusive; Connecting to the River — ecology & resiliency; and Glass & Light — uniquely Toledo.

Ms. Weisz stated that the tour started with the way the site looks today. It highlights nodes which already existed while connecting new nodes. She noted that, starting at Industry Square, the walkway is narrow, but it is a gateway transformed by extending the walkway, and providing places for biking, walking, and fishing access. She observed that Promenade Park has potential for an amphitheater. The Sandpiper docking is already there, and opportunities are available to enhance the docks, and to connect streets to water access. She also discussed developing bio swales, again advancing the goals of connecting boats, bikes, and walkers. The area outside One Seagate further enhances this area, and provides wheelchair access and curving access to the MLK Bridge for people and cyclist access, and will improve accessibility for all. The areas heading toward International Park also will be enhanced. The "Hill" pavilion will become a COVID-related Sculpture; the number of trees will increase; lawns will be healthier; and the area will include more natural cover for rowing and kayaking, improving the area as a place for play. The rock jetty will protect the cove from trash and debris. The dock restaurants will have an enhanced walkway.

Mr. Zenk reiterated that the new access created to the MLK Bridge will make it more accessible.

Ms. Luetke asked about the other side of the river toward Owens Corning. Mr. Zenk responded that Mr. Nate Ramsey and his team recently have been working with Owens Corning and making the necessary connections.

Mr. Fritz Byers thanked Ms. Weisz and Ms. Marusic for their presentations. He stated that this is an exciting project, and he loves the language of "glass and light" and "meander a little bit long." He noted that these efforts are defining Metroparks Toledo's Mission and Vision. Mr. Byers said that members of the Board and others who work for Metroparks Toledo stated at last night's event that thanking the voters first and foremost was the way to begin. The trust that the votes and taxpayers have placed in Metroparks is essential. Mr. Byers recognized the community's support of this project and many other projects. Mr. Byers expressed the significant concern for the area's natural resources, and discussed how communities are redefining waterfront property. Metroparks Toledo and community-wide partnerships and support are making the success of this project possible. Mr. Byers stated that he can feel the excitement of what is transpiring in this community. Mr. Byers shared that growing up in Kansas City, he encountered one of the greatest distance runners in the world, Jim Ryun. Mr. Byers analogized this project to Mr. Ryun's efforts, in that to be a great runner you have to put in the hard work but have the humility to pull it off.

Mr. Byers again thanked Ms. Weisz and Ms. Marusic and everyone at Metroparks Toledo who worked on this project.

Mr. Kevin Dalton stated that he has had the opportunity to visit schools near Glass City Metropark and people are excited about this park. He stated that families love that the park is within walking distance. This project is providing a vibrant outlook for the kids, and is bringing smiles to them in addition to all of the other benefits to the community.

Ms. Luetke stated that an exciting aspect of this project is giving people a place to go and escape their computer screens. She discussed how much human connection means to everyone's wellbeing. Additionally, she loves that this is a great illustration of encouraging people to get outside in an inviting way. Visitors can train for a marathon but also have lots of fun. Ms. Luetke expressed her appreciation for all the hard work put into this project.

Mrs. Lera Doneghy added that she appreciates the focus on inclusivity, and how Metroparks is providing opportunities to be included and not excluded from having access to the park. Metroparks Toledo has been able to bridge the gap and bring people together. She stated that this is a really cool project.

Mr. Savage said he has nothing more to say on this exciting project other than it is reshaping the downtown and connecting people to the Metroparks.

B. Treasurer's Report - Wendy Garczynski, Comptroller

Mrs. Wendy Garczynski stated that the general fund budget versus actual is running as anticipated. Revenue is a little high, because a number of properties have received exempt status.

The final payment on the wide area mower has been made. Metroparks Toledo has nine "Then and Now" certifications necessary for the month of April. Mr. Savage asked if there has been a change in the process. Mrs. Garczynski responded that the process to reduce the Then and Nows is working. She noted that the process of having vendors directly add purchase order numbers on the invoices before sending them has cut down on the Then and Nows.

Ms. Garcynski reported that Metroparks Toledo has a new fund for debt service because the first-half property tax collections are the first since bonds were placed last fall. Metroparks Toledo must receipt the portion of anticipated funds received into debt service.

4. BOARD APPROVAL OF CONTRACTS, DEEDS, AGREEMENTS, ETC.

A. Mr. Byers offered and moved for adoption of the following resolution, with a second by Ms. Luetke:

After discussion and upon unanimous vote the resolution was declared duly adopted and recorded in the appendix to these minutes.

B. Mrs. Doneghy offered and moved for adoption of the following resolution, with a second by Ms. Luetke:

C. Mr. Dalton offered and moved for adoption of the following resolution, with a second by Mr. Byers:

Resolution No. 22-22 – Authorization of Contract for Electrical Supply Service

Ms. Garczynski reported that it is time to renew the contract. This is an approval to sign the contract for three years. Mr. Savage mentioned that the estimated savings over the next three years is expected to be about \$20,000.00. Mrs. Garczynski noted that this is just approval to sign the contract for quoting. The actual contract will come before the Board for approval in May or June.

After discussion and upon unanimous vote the resolution was declared duly adopted and recorded in the appendix to these minutes.

D. Mr. Byers offered and moved for adoption of the following resolution, with a second by Mrs. Doneghy:

Resolution No. 23-22 - Contract Approval, Glass City Metropark, Phase 2 Cabana Buildings - Kit of Parts

Mr. Brad Hooven is requesting funds for the materials to start the drawings, construction, etc. for the Glass City Phase 2 Cabana buildings.

After discussion and upon unanimous vote the resolution was declared duly adopted and recorded in the appendix to these minutes.

E. Mr. Byers offered and moved for adoption of the following resolution, with a second by Mrs. Doneghy:

Resolution No. 24-22 - Approval of Lease Agreement with Black Swamp Cattle Company

Dr. Tim Schetter discussed the effect of natural disturbances (grazing and fire) and loss of bison going back to the same year Ohio became a state. Although Metroparks Toledo has a deer population, they only focus on plant tips. Cattle have been used by the Nature Conservancy for years, and are a very effective method of improving habitat quality. This is a grazing study for the first year.

Mrs. Doneghy asked if there are any neighbors located near the grazing spot. Dr. Schetter stated that no, this is an area inside Oak Openings Preserve. Mrs. Doneghy asked if visitors will be able to see the cattle. Dr. Schetter responded that, yes, visitors will be able to see them. Ms. Luetke asked how long it will take to see the impact of the grazing. Dr. Schetter said the impacts will take a couple of years. Historically, for example when wildfires occur, the grazers are drawn to the new growth. The cattle will not graze the same area every year.

Mr. Dalton asked approximately how many acres will benefit. Dr. Schetter said if it were limited to just prairies, it would be about 300-500 acres, but it could be up to 1000 acres if the area is increased. Mr. Dalton asked why not use bison. Dr. Schetter explained that bison are harder to manage than cattle. He noted that fencing is very expensive and if bison were to get outside the fence, they could be very destructive not only to Oak Openings but to neighboring farms.

After discussion and upon unanimous vote the resolution was declared duly adopted and recorded in the appendix to these minutes.

5. BOARD INITIATED TOPICS AND DISCUSSIONS

Mrs. Doneghy thanked the attendees and staff. Mr. Dalton thanked those working in the park district, and noted that the Board of Park Commissioners really appreciates everything they are doing in the parks.

Mrs. Doneghy said she attended the All Employee Open House where staff had a chance to see the overall plan for Glass City Metroparks and the Riverwalk. Staff were able to ask questions and take time to get to know one another. Mrs. Doneghy shared that it was a wonderful event and a great opportunity to meet and talk with staff in-person.

With no further business or action to be taken, Mr. Byers made a motion to adjourn the Board meeting at 9:47 a.m., which was seconded by Ms. Luetke and approved.

1. NON-RESOLUTION BOARD ITEMS

President Scott Savage called the meeting to order at 9:36 a.m.

Mr. Savage led the Pledge of Allegiance.

Mr. Kevin Dalton motioned to approve the consent agenda, Mrs. Lera Doneghy seconded, approved.

2. BOARD APPROVAL OF CONTRACTS, DEEDS, AGREEMENTS, ETC.

Contracts, Deeds, Agreements, Etc.

A. Mrs. Doneghy offered and moved for adoption of the following resolution, with a second by Mr. Dalton:

Resolution No. 25-22 – A Resolution Authorizing the Issuance of Land Acquisition and Improvement Tax Anticipation Bonds, Series 2022

Mr. Matt Cleland stated that last year Metroparks Toledo

It is important to note that these are not additional monies, nor new monies, rather an opportunity to borrow funds from levy proceeds to meet the needs of the construction schedule. By 2030 the Riverwalk will be complete and all of the debt will be serviced.

Mr. Fritz Byers inquired if a portion of these bonds will pay back the previously borrowed funds from last year. Mr. Cleland confirmed that the previously issued bonds will be retired upon receipt of the 2022 issue. Four local and regional banks responded to the Metroparks request, with the winning bid coming from Key Bank at a fixed rate of 2.98%. This will be a direct placement as opposed to a public issuance. Mr. Byers mentioned that Metroparks Toledo will be saving on transaction costs; however, what is a typical cost of this? Mr. Cleland responded that the transaction is not complete but he estimates cost of issuance to be \$30,000-\$40,000 which Metroparks Toledo will be paid from funding received from the tax levies through normal operations and budget planning. Mr. Byers inquired what the cost of issuance would have been had the bonds been sold through a public issuance. Mr. Cleland responded several hundred thousand dollars. Mr. Byers stated that this is all very good and illustrates the careful stewardship of the communities' monies.

Mr. Savage stated that on the bid sheet, the PNC rate could initially look more competitive, but after walking through the entire bid package, Key Bank did provide the most competitive package. There is a tremendous amount of communications through this entire process, and a lot of work went into this effort. Mr. Savage acknowledged Mr. Cleland and his team for this work.

Mr. Byers appreciates keeping this all local, flexibility we have within the community and stands as a driver in economic health.

Mrs. Doneghy feels the public will be very pleased with the diligence of these monies. Mr. Byers shared that this was a very fiscally creative process that resulted in an extremely successful solution.

After discussion and upon unanimous vote the resolution was declared duly adopted and recorded in the appendix to these minutes.

With no further business or action to be taken, Mr. Byers made a motion to adjourn the Board meeting at 9:51 a.m., which was seconded by Mr. Dalton and approved.

1. Revenues, Expenditures and Changes in Fund Balances – Budget vs. Actual – General Fund as of 04/30/2022

<u>Description</u>: This report is a comparison of the General Fund budgeted revenues, expenditures and transfers compared to actual revenues, expenditures and transfers by month as well as year-end. The approved 2021 general operating fund budget and actual cash basis revenues, expenditures and transfers are represented. Year to date budget distribution is based upon a 12 month proration with the exception of salaries and fringe benefits. Salary and fringe benefit budget distribution is based upon a proration of 26 pay dates. (See Appended Statement – Attachment A).

<u>Current State</u>: The annual budget for property tax revenue has been reduced to reflect the \$7 million that is appropriately allocated to the debt service fund. The year to date budget for sales revenue is zero because the Canal Experience and kayak rental have not begun for 2022. Year to date expenditures are as expected through April.

2. Receipts, Disbursements and Changes in Fund Balances – Budget vs. Actual – All Funds as of 04/30/2022

<u>Description</u>: This report is a comparison of annual budgeted receipts and disbursements compared to cash basis actuals as of month end. Then and now is a certification by the Board that funds were available when an obligation was made (then) and at the time of certification (now) for obligations made prior to certification. (See Appended Statement – Attachments E).

<u>Current State</u>: There are seven items requiring certification by the board for the month of April. Beginning March 31st the finance department is requiring that all vendor invoices be printed with the Metroparks purchase order number on the document. Both vendors and Metroparks staff are being held accountable for this requirement which, among other benefits, strives to reduce the need for then and now certifications.

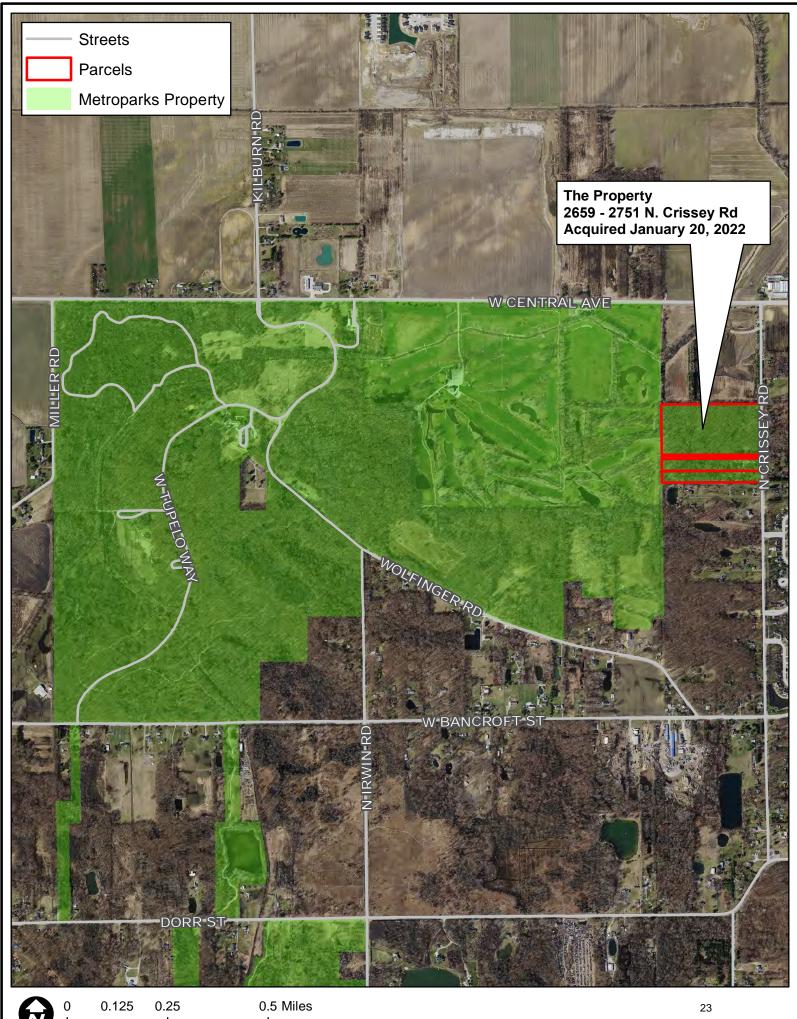

Sealed proposals for bidding on district-wide heating, ventilation and air-conditioning (HVAC) equipment preventative maintenance, corrective maintenance repairs, and backflow prevention device testing were received Wednesday, May 18, 2022. One bid was received from Coleman Systems, Inc. of Sylvania, the apparent lowest and best bidder.

The Scope of Work consists of:

- Prescribed pre-cooling season and pre-heating season preventative maintenance to inventoried HVAC equipment.
- Corrective maintenance repairs to HVAC equipment as authorized.
- Testing of backflow prevention devices.

DESCRIPTION:

Several factors, including the anticipated growth of the agency, current automotive supply chain issues and increasing vehicle maintenance costs, prompted Metroparks to complete an assessment of our current fleet management practices. When benchmarking with other government agencies, several consulted had shifted to a fleet leasing program in order to proactively achieve multiple objectives. Some of these include: reducing capital expenditures and maintenance costs, increasing fuel efficiency, and reducing the administrative burden associated with acquisition, up-fitting, and disposition of vehicles.

As the highest scoring provider of fleet management services in the joint purchasing program Sourcewell, Enterprise Fleet Management, Inc. (EFM) is the most qualified to help Metroparks achieve these objectives. Their purchasing volume enables priority ordering directly from major manufacturers at lower cost and have worked with numerous local and state agencies.

Using a phased approach, Metroparks staff will work with a dedicated Client Strategy Manager to make decisions on which vehicles to cycle in and out of the fleet, how to best account for growth, and how to better inform future use of electric or alternate fuel vehicles. The first phase will be derived from the attached list of vehicles to be declared surplus.

RECOMMENDATION:

Authorize Metroparks Toledo's Executive Director to negotiate and execute necessary documents and agreements with Enterprise Fleet Management, Inc., for the leasing and disposition of vehicles to be used by Metroparks Toledo, at an annual cost not to exceed \$250,000.00.
